- **3. May 23, 2019 Meeting Summary -** The meeting Summary for the May 23, 2019 was approved as published.
- 4. Executive Director's Report -
- Financial Report A Financial Report distributed including a Balance Sheet, Profit & Loss Statement and Budget Analysis to June 25, 2019. There were no comments or questions about the Financial Report.
- Final Budget Amendment F.Y. 2018-2019 Riley distributed a proposed final budget amendment making budget adjustments to address extra costs incurred for the Annual Dinner and in Operations-Printing & Copying. The Committee Agreed to recommend approval of the Budget Amendment Resolution 2019-06 to the full Council on July 11, 2019.

- Legislative Update- Riley reported on the LOCC's Action Request supporting SB 5
 as well as on opposition to SB 330 and SB 592. He also discussed the Legislative
 Summary Table that was included in the Agenda Package. The Table provides
 current status of bills of interest.

VCOG Website Upgrade-. Devon Cichoski, Chief Communications Officer for Celtis Ventures, Inc., the consultant retained to complete VCOG Website upgrades, presented a preview of the upgraded site. Cichoski addressed questions from the Committee and suggestions for further tweaking. The question of streaming VCOG Videos was tabled until the next Fiscal Year. Riley advised that the 2019-2020 Operating Budget included additional funds for further refinements to the website including pursuing video streaming features.

The Committee revisited discussion of the July 11, 2019 Council Meeting Agenda and the scheduled report from the VCTC. Committee Member Crosswhite wanted to be sure there would be enough time for the Safe Passages Report including questions. The question as to whether Executive Director Kettle might discuss the VCOG-VCTC Merger was discussed and the Committee concluded that omission of this discussion would be preferable. Riley advised that Mr. Kettle intended to provide an outline of his proposed report content so Riley would be aware of these details before publishing the agenda. It was also concluded that the VCTC Report should be placed on the Agenda before the Safe Passages Report and that the Chair would ensure there was sufficient time for both presentations.

Chair Adam suggested that County CEO Mike Powers be invited to be at the September 12 Council Meeting to provide an update on County issues of interest to all member agencies including but not limited to oil and gas drilling, gun show issue, the Homeless Fund of \$2 million, wildlife corridors and the VCMC.
