1. Call to Order - 2:10 p.m.

Members on Zoom Call: Chair Crosswhite, Chair-elect Kildee, Immediate Past Chair Parvin, Member-at-Large Adam.

Absent: Member At-Large Haney

Staff on Call: Executive Director Riley, Chris Williamson, Housing Programs Specialist, Mina Layba, Legislative Affairs Manager, City of Thousand Oaks; Brian Chong, Assistant to the City Manager, City of Moorpark, Roger Pichardo, Senior Management Analyst, City of Camarillo, Amanda Fagan, Director of Planning and Policy, V.C.T.C.

- 2. Public Statements There were no public statements submitted for the record.
- **3.** July 22, 2021, Meeting Summary The meeting Summary of the July 22, 2021, Committee Meeting was reviewed with several typographical changes suggested. A MOTION was made by Parvin to approve the July 24, 2021, Admin Committee Meeting Summary. **SECONDED** by Member Adam. Motion Carried without opposition.

4. Executive Director's Report -

- a. Financial Report- The Financial Report was presented by Riley. Riley advised that Payments for REAP Reimbursement Invoice Nos. 2, 3, 4 for April, May, June have been received from SCAG. Invoices 5 and 6 are pending. All Member Assessments for 2021-2022 totaling \$64,992 have been paid. An additional \$3,000 donation for the Annual Dinner has been received from Southern California Edison. Riley advised that the SLIP Insurance Premium has been paid and he outlined several REAP expenditures.
- b. Proposed Meeting Schedule 2022 and Annual Dinner Issue- The Committee discussed the proposed VCOG Meeting Schedule. The Annual Dinner is currently scheduled for June 9, 2022. To avoid having two Annual Dinner Events in the same fiscal year (2021 Event scheduled for October 21, 2021) Riley suggested the Annual Dinner for 2022 be moved to September 8 and the September 8 Council Meeting moved to August 11, or October 13, 2022. Member Parvin suggested the choice be October 13, 2022, as many of the member cities go dark in August. The Committee concurred with these changes and the Admin Committee Meeting schedule can be adjusted accordingly. Riley will publish a revised Schedule for the Committee, and this will be placed on the VCOG Council Meeting Agenda for approval on November 4, 2021.
- c. SCAG Sub-region, District 46 Representative- Riley reported David Pollock's term as District 46 Representative will expire in January 2022 creating a vacancy. Riley will place an item on the November 4 VCOG Council Meeting to issue a Notice of Call for Candidates for the position to Council Members for Moorpark, Simi Valley. The Notice would be dated November 5, 2021 (following the Council Meeting), requiring letters of interest by December 27, 2021, and an Election on January 10, 2022, in Moorpark if there are two or more declared candidates.

- d. Preview of VCFJC Evaluation Research Report- A copy of the Final Report for the Evaluation Study of Ventura County Family Justice Center (VCFJC) was included with the Committee Meeting Agenda Materials. The Report will be presented formally to the Full VCOG Council on November 4, 2021, by Dr. Molly George, CLU, Department of Criminology and Criminal Justice. Riley suggested the report be sent to the Council in advance or the other meeting agenda materials. The Committee concurred.
- **5. REAP Update:** Chris Williamson reported on the REAP Project status. There are funds remaining in REAP Project No. 2. Which produced Localized Content for Documents, governing affordable housing development processing by local governments. Williamson suggested we could use these remaining Project 2 funds to prepare a new summary of the latest legislation passed in 2021 to supplement the previously published material. The Committee concurred. Williamson continued his report providing the status of each of the three other REAP Projects.
- **Project #3** This project develops a template for an Inclusionary Housing Ordinance. The consultant has completed a summary of the six existing Inclusionary ordinances adopted by cities in Ventura County and throughout the state. This report has been presented to the City Managers Group. A first draft of an ordinance template should be ready by the end of the calendar year.
- **Project #4** Regional ADU Program for Prefabricated and Garage Conversions- VCOG Staff is working with SCAG and OCCOG to develop a work product that can be provided to jurisdictions in the region and can be tailored to their requirements. OCCOG is taking the lead to develop a scope of work, for an MOU for a Joint Project.
- **Project** #5 Regional CEQA Streamlining VMT Adaptive Management and Mitigation Program. Amanda Fagan reported that VCTC and VCOG Staff have been meeting with the primary consultant Iteris, to develop the guidelines and analysis for the VMT Adaptive Mitigation Program. A Fact Sheet has been developed to communicate the purpose and requirements of the program. This has been distributed to the City Managers Group. The consulting team has been working on a few of the background tasks including a Memorandum that outlines the requirements for adopting a fee program. Chris stated the project is designed to streamline the CEQA Process for any project but particularly for housing projects and it is not intended to be a revenue producer.

Staff will be preparing VCOG's first Quarterly Report to SCAG for submittal early I October. Theis report should be ready to be given to the full Council during the November Meeting. Chair Crosswhite asked staff to prepare some bullet points about REAP and the CLU Research Project for her remarks at the Annual Dinner. Riley, Williamson, and Fagen will collaborate.

- 6. Plans for Future Council Meeting- 11/4 Riley reminded the committee that the agenda includes the CLU- VCFJC Evaluation Research Project Report and an invitation has been extended to Cpt. Robert "Barr" Kimnach III, USN- New Commander, Naval Base Ventura for an introduction only. Member Adams suggested we see if a representative from Livable California could attend to present their platform. Livable California is a non-profit advocate for the empowerment of local governments to foster equitable, self-determined communities offering a path to regain local government authority from the clutched of the legislature. Riley will contact Livable California to determine the availability of a representative to appear.
- **7.** Annual Dinner Prospects Riley reported that, in the event the County requires proof of COVID-19 Vaccinations for admission to group events held indoors, he had requested a quote from EventScan for pre-screening of attendees. The Committee felt this was unnecessary and that we should wait and see if the current mask requirements are changed to include

vaccination certifications before the October 21 Event. Riley reported we have about 60 RSVPs for the dinner. Crosswhite reported that the city was seeking an alternate for the entertainment as the act scheduled for the September 9 event was not available for October 21.

Adjournment – The conference call concluded, and the meeting adjourned at 3:00 p.m.

HIGHLIGHTS FROM November 4th REGIONAL COUNCIL MEETING

ACTION

REGIONAL COUNCIL APPROVES 27 LAST MILE FREIGHT PROJECTS

The Regional Council today approved 27 proposals as a part of the Last Mile Freight Program Phase 1 to be awarded \$10 million. The Regional Council also approved a contingency list of projects that can be considered should additional funding become available through the Mobile Source Air Pollution Reduction Review Committee.

The <u>Last Mile Freight Program</u> Phase 1 is the initial step towards implementing freight-related clean vehicles/equipment and infrastructure to support cleaner air goals. The focus on last mile freight operations is particularly significant as trucks serving the regional distribution market constitute nearly 90 percent of total truck trips in the region.

Following approval of the project list by the Mobile Source Air Pollution Reduction Review Committee, SCAG staff will work closely with the awarded agencies to further define the scopes of work and develop a project initiation schedule and budgets. IAN CARLTON SPEAKS ON ASSESSING THE POTENTIAL IMPACTS OF SENATE BILL 9 ON HOUSING SUPPLY

Ian Carlton, Co-Founder of MapCraft Labs, presented to the Regional Council on research conducted by UC Berkeley's Terner Center for Housing Innovation on a study which used parcel-level data and an economic model to assess the potential impacts of Senate Bill (SB) 9's provisions on housing in the SCAG region.

Signed into law by Governor Newsom in September 2021, SB 9 allows for by-right lot split and duplex developments on single-family residential parcels. The Terner Center study indicates that approximately seven percent of the region's single-family parcels would be financially feasible to develop under SB 9's provisions, approximately

300,000 new homes in the SCAG region; however, this potential supply increase could address a substantial share of the region's housing need and is significant when compared to recent housing production. Carlton concluded that it is unknown how many homeowners will want to take advantage of this program and that jurisdictions have wide implementation authority to create programs that will work for their communities.

ACTION

REGIONAL COUNCIL APPROVES FUNDING FOR THE INCLUSIVE ECONOMIC RECOVERY STRATEGY

The Regional Council today accepted \$3.5 million in one-time funds from the California Workforce Development Board to support the implementation of recommendations in the Inclusive Economic Recovery Strategy.

The Inclusive Economic Recovery Strategy, adopted by the Regional Council in July 2021, is focused on economic recovery from the pandemic and provides opportunities to ensure inclusive economic growth for SCAG's lower-income communities and communities of color. Through Assembly Bill 129, and with support from Senator Susan Rubio (D-West Covina), SCAG was allocated one-time funds to implement several core recommendations of the strategy including:

- Supporting expansion of the number of, and access to, middle-wage jobs
- Strengthening supply chains and access to contracting opportunities
- Construction apprenticeships and training
- Providing regional data
- · Addressing human capital needs

CONNECT SOCAL AMENDMENT NO. 1 & 2021 FTIP CONSISTENCY AMENDMENT NO. 21-05

Since the adoption of Connect SoCal, the 2020 Regional Transportation Plan/Sustainable Communities Strategy, in September 2020, several projects included in the plan's Project List have experienced technical changes that are timesensitive. In addition, the county transportation commissions in the SCAG region have also identified new project priorities in addition to projects that are no longer priorities. The amendments to Connect SoCal and the 2021 Federal Transportation Improvement Program (FTIP) ensure these projects move forward in a timely manner. The amendments will now be forwarded to the appropriate federal and state reviewing agencies for final approval. SUBJECT: Additional 5% REAP SRP Subregional Allocations Announced

DATE: November 18, 2021

Recommendation:

Receive Report and Continue Consideration for the use of the additional funds to January 2022. for Period ending November 15, 2021.

Discussion:

To meet the dynamic project management needs of our subregional partners, SCAG has increased the allocation available for each subregional partner by 5%. This would mean an additional \$21,600 for use on VCOG REAP Projects. The additional funds can only be used to increase the budget for new or existing tasks in the executed scope of work approval forms (SAF) or for VCOG project management. It cannot be used for new projects or for administrative costs.

The increase was a result of cost savings in the REAP program and SCAG's total REAP amount remains the same. The deadline to program all or a portion of the additional 5% is April 1, 2022.

Possible Projects to consider include:

- > Additional funding for Project 3 If the Inclusionary Zoning Ordinance generates interest from city attorneys the project may need more funding.
- Allocate additional funds to the ADU Project 4, raising the VCOG Contribution to about \$70K

In addition to the requirement for VCOG Members and Alternates (VCOG Members) to file an annual FPPC FORM 700 Statement of Economic Interest, VCOG Members are required to complete a minimum of two (2) hours of AB 134 Ethics Training within one year of being appointed, and every two years thereafter.

A reminder email (or letter) from the Ventura County Clerk of the Board's Office has been sent to each member and alternate on the VCOG Council that must renew or complete his/her Ethics Training.

Members not in compliance may obtain online training from the Fair Political Practices Commission at http://localethics.fppc.ca.gov/login.aspx. Some member cities also offer this training on a periodic basis. At the conclusion of the training, a certificate indicating the participation time is available for the member to print, sign and email to clerkoftheboard@ventura.org or mail to:

Recommendation:

The Committee Recommend the Consideration of VCOG Resolution 2022-01 Invoking AB 361 for Subsequent VCOG Meetings to the VCOG Council on January 13, 2022

Background:

On September 16, 2021, Governor Newsom signed Assembly Bill 361 (2021-2022) ("AB 361"), which incorporated into California state law some aspects of the teleconferencing rules that have applied by Executive Order to local public agencies during the COVID-19 pandemic. Notably, because AB 361 included an urgency measure, the law was immediately effective as of the date of the Governor's signature. AB 361 provides that it sunsets on January 1, 2024.

Benefits of operating under AB 361 during the COVID-19 pandemic, as opposed to under the normal open meeting laws, include the following:

- Agendas need not be posted at all teleconference locations;
- Each teleconference location need not be identified in the notice and agenda of the meeting;
- Each teleconference location need not be accessible to the public; and
- A quorum of the members of the legislative body do not need to participate in the meeting from locations within the boundaries of the territory over which the public agency exercises jurisdiction.

Following are requirements for invoking AB 361 the <u>first</u> time that a public agency does so:

- 1. There must be a "proclaimed state of emergency," as there is currently, in that the Governor's State of Emergency Declaration, issued on March 4, 2020, has not been lifted, and
- 2. One of the following three circumstances must exist:
 - 1. State or local officials have imposed or recommended measures to promote social distancing;
 - 2. The meeting is held to determine, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to health or safety of attendees; or
 - 3. The majority of the legislative body has voted that, as a result of the emergency, meeting in person would present imminent risk to the health or safety of attendees.

If a public agency wishes to consider invoking AB 361 for <u>subsequent</u> meetings, the following is required for those subsequent meetings:

- 1. The proclaimed state of emergency must remain active; or
- 2. State or local officials have imposed or recommended measures to promote social distancing; and
- 3. Not later than 30 days after teleconferencing for the first time under the AB 361 rules, <u>and every 30 days thereafter</u>, the Legislative body shall make the following findings by majority vote:
 - The legislative body has reconsidered the circumstances of emergency, and at least <u>one</u> of the following circumstances exist:
 - 1. The state of emergency continues to directly impact the ability of the members to meet safely in person; or
 - 2. State or local officials continue to impose or recommend measures to promote social distancing.

If a public agency were to invoke AB 361, following are notice and participation requirements:

Notice Requirements

 Each notice of the meeting and agenda must identify the means by which members of the public may access the meeting and offer public comment by a call-in option or an internet-based service option (does not need to be both)

Participation Requirements

 Cannot require public comments to be submitted in advance of the meeting (although the agency may provide this as an option along with the call-in or internet-based service option)

- Public must be able to attend via call-in option or internet-based service option (does not need to be both)
- Public must be able to address the legislative body "directly" via call-in option or internet-based service option
- The public agency must provide an opportunity for the public to address the Legislative body and "offer comment in real time"
- If there is a disruption that prevents the public agency from broadcasting the meeting using the call-in option or internet-based service option, or if there is a disruption within the public agency's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the body "shall take no further action on items appearing on the agenda until public access to the meeting via the call-in option or internet-based service option is restore"
- Timing of Public Comment Period
 - o If a legislative body does not provide a timed public comment period, but takes public comment separately on each agenda item, it shall allow a "reasonable amount of time per agenda item to allow public members the opportunity to provide public comment," including time for members of the public to register to provide comment or otherwise be recognized for the purpose of providing public comment
 - If a legislative body provides a timed general public comment period that does not correspond to a specific agenda item, it shall not close the public comment period or the opportunity to register until the timed general public comment period has elapsed
 - If a legislative body provides a timed public comment period for each agenda time, it shall not close the public comment period or the opportunity to register until the timed public comment has elapsed

A Final Note

The current teleconferencing Executive Orders will remain in effect, if not rescinded, until September 30, 2021. Therefore, public agencies should have a couple of weeks to assess how to conduct their meetings in light of AB 361.

And, if legislative bodies will not be meeting until October 2021, AB 361 provides that its provisions may be invoked <u>once</u> under the conditions described, without having the legislative body make, by majority vote, the legislative findings noted above.

Discussion:

At the November 4, 2021, VCOG Council Meeting the Council heard a presentation from the Livable California Organization and from proponents of the "Our Neighborhood Voices Initiative." The initiative seeks to amend Article XI of the California Constitution to make zoning and land-use locally controlled. The measure was Introduced by Assembly Member AI Muratsuchi and co-authored by State Senator Stephen Glazer as ACA7. The proposed amendment does not affect Fair Housing Laws or CEQA requirements but does supersede any previously enacted State laws such as SB9 & SB10.

Staff has prepared the attached Draft VCOG Resolution No. 2022-02 for possible consideration by the VCOG Council on January 13, 2022, if recommended by the Administrative Committee.

VENTURA COUNCIL OF GOVERNMENTS RESOLUTIO NO. 2022-02

A RESOLUTION OF THE GOVERNING BODY OF
THE VENTURA COUNCIL OF GOVERNMENTS EXPRESSING SUPPORT FOR THE
"BRAND-HUANG-MENDOZA TRIPARTISAN LAND USE INITIATIVE" TO AMEND
ARTICLE XI OF THE CONSTITUTION OF THE STATE OF CALIFORNIA TO MAKE
ZONING AND LAND USE COMMUNITY AFFAIRS, AND NOT OF STATE INTEREST

WHEREAS, the Legislature of the State of California in recent years has proposed, passed, and signed into law thirty-six bills addressing a range of land use planning and housing issues; and

WHEREAS, many of these bills usurp the authority of local jurisdictions to determine for themselves the land use policies and practices that best suit each city and its residents and instead impose "one-size-fits-all" mandates that do not consider the unique needs and differences of local jurisdictions throughout the State of California; and

WHEREAS, many of these bills do not provide incentives or requirements for low-income affordable or moderate-income workforce housing, but instead impose new policies that will incentivize speculation and result in the addition of market-rate or luxury housing, thereby eliminating the opportunity for local jurisdictions to implement effective policies that will create more affordable housing and affirmatively further fair housing practices; and

WHEREAS, the ability of local jurisdictions to determine for themselves which projects require review beyond ministerial approval; what parking requirements are appropriate for various neighborhoods; what housing plans and programs are suitable and practical for each community; and what zoning should be allowed for residential properties, rather than having these decisions imposed upon cities without regard for the unique circumstances and needs of each individual community, is a matter of critical importance to the Ventura Council of Governments (VCOG).; and

WHEREAS, the Governing Body of VCOG hereby determines that local government entities are best able to assess and respond to the unique needs of their respective communities and hereby objects to the proliferation of State legislation (including SB 9 and SB 10) that would deprive us of that ability.

NOW, THEREFORE, THE GOVERNIING BODY OF THE VENTURA COUNCIL OF GOVERNMENTS DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. That the Governing Body VCOG is opposed to the legislature of the State of California continually proposing and adopting legislation that overrides the zoning and land use authority of local government and inhibits the ability of local government to effectively plan for and implement policies to stimulate the efficient production of affordable housing in the County of Ventura.

SECTION 2. That the Governing Body of VCOG supports the Brand-Huang-Mendoza Trip artisan Land Use Initiative to ensure that zoning and land use authority rests with the local government entities that represent the communities in which the residents reside, and to allow local government to participate in solving our affordable housing crisis through solutions that effectively address the unique needs and conditions of each local community.

SECTION 3. That the Governing Body of the Ventura Council of Governments incorporates each recital set forth herein above.
