On March 17, 2020, the Governor issued Executive Order N-29-20 suspending certain provisions of the Raiph M. Brown Act in order to allow for local legislative bodies to conduct their meetings completely telephonically or by other electronic means. On June 11, 2021, the Governor subsequently issued Executive Order N-08-21 maintaining the suspension of certain provisions of the Brown Act to continue to allow for local legislative bodies to conduct their meetings completely telephonically or by other electronic means through September 30, 2021. In accordance with AB361, VCOG will continue to conduct its meetings by teleconference, its councilmembers will participate in the meeting from individual remote locations, and no physical location will be open to the public for the VCOG meeting. # VCOG ADMINISTRATIVE COMMITTEE November 18. 2021 ZOOM CONFERENCE CALL 33 E. High St., Ste. 200, Moorpark, CA 93021 Meeting Summary

#### 1. Call to Order - 2:03 p.m.

Members on Zoom Call: Chair Cross white, Chair-elect Kildee, and Member-at-Large Adam.

Absent: Immediate Past Chair Parvin; Member At-Large Hanev

Staff on Call: Executive Director Riley, Chris Williamson, Housing Programs Specialist, Mina Layba, Legislative Affairs Manager, City of Thousand Oaks; Brian Chong, Assistant to the City Manager, City of Moorpark,

- 2. Public Statements There were no public statements submitted for the record.
- **3. September 30, 2021, Meeting Summary** The meeting Summary of the September 302, 2021, Committee Meeting was reviewed. A **MOTION** was made by Kildee to approve the September 30, 2021, Admin Committee Meeting Summary. The motion was **SECONDED** by Member Adam. The motion carried without opposition.

#### 4. Executive Director's Report -

- a. Financial Report- The Financial Report was presented by Riley. Riley advised that Payments for REAP Reimbursement Invoice Nos. 2, 3, 4, and 5 for April, May, June, and July have been received from SCAG. Invoices 6 and 7 are pending.
- **b. SCAG Update- November 2021-** The SCAG Monthly Update had been included in the Committee's Agenda Materials.
- c. Additional 5% REAP SRP Allocations Announced To meet the Dynamic project management needs of its sub regional partners (SRP), SCAG has increased the allocation of REAP Funds available for each SRP by 5%. This would equate to and additional \$21,600 for use on VCOG REAP Projects. The additional funds may only be used to increase the budget for new or existing tasks in the executed scope of work approval forms (SAF) or for VCOG management. It cannot be used for new projects or for administrative costs. Riley advised Possible Projects to consider include:
  - > Additional finding for Project 3- If the Inclusionary Zoning Ordinance generates interest from city attorneys the project may need more finding.
  - > Allocate additional funds to the ADU Project 4, raising the VCOG Contribution to about \$70,000.
- d. Ethics Training Reminder and Financial Disclosure (FORM 700) Riley reminded members that, In addition to the requirement for VCOG Members and Alternates (VCOG Members) to file an annual FPPC FORM 700 Statement of Economic Interest, VCOG Members are required to complete a minimum of two (2) hours of AB 134 Ethics Training within one year of being appointed, and every two years thereafter.

- 6. Virtual Meeting Declaration- Resolution- Assembly Bill 361 (2021-2022) Riley presented details of Assembly Bill 361 (2021-2022) ("AB 361"), which incorporated into California state law some aspects of the teleconferencing rules that have applied by Executive Order to local public agencies during the COVID-19 pandemic. Notably, because AB 361 included an urgency measure, the law was immediately effective as of the date of the Governor's signature. AB 361 provides that it sunsets on January 1, 2024. Governing bodies are required to make this declaration on each instance where they will be conducting their public meetings virtually. This item will be placed on the VCOF Council Meeting Agenda for January 13, 2022.
- 5. REAP Update: Chris Williamson reported on the REAP Project status. (Taken Out of Order)
- Project #2 We will be working on an update of the Legislative Summary produced by this project initially to incorporate the impacts of SB 9 and SB 10 and other newly passed legislation. Staff will try to complete this update be the end of the month.
- **Project #3** This project develops a template for an Inclusionary Housing Ordinance. The consultant expects to have the final draft of the template ready to distribute to the city attorneys for their comments by the end of December. The consultant has completed a summary of the six existing Inclusionary ordinances adopted by cities in Ventura County and throughout the state. This report has been presented to the City Managers Group. A first draft of an ordinance template should be ready by the end of the calendar year.
- **Project #4** This project is on hold, waiting for the development of a Memorandum of Understanding (MOU) and a Scope of Work between VCOG, OCCOG and GCCOG as a joint project. An outline draft of the MOU was approved by the VCOG Council on November 4.
- Project #5 This is the VMT-CEQA Streamlining Program. A recent meeting of the project consultants and eight of the eleven agency planners and transportation staff with a technical roll-out of the program to gather comments and input from the agencies. Our objective is to have the program ready by the spring of 2022. Chair Cross white asked if there had been any discussion or recommendations included regarding fees paid in lieu of affordable units. Chris replied that this had not been included in the discussions. The committee discussed the pros and cons of in-lieu fees.
- 7. Plans for Future Council Meeting- January 13, 2022 Riley reminded the committee that Cpt. Robert "Barr" Kinch III, USN- New Commander, Naval Base Ventura was included on the January 13, 2022, Agenda for an introduction. Riley stated that he had not heard back from Supervisor Ramirez about a possible speaker to discuss the water supply issues facing Ventura County.

Riley asked the committee to discuss a recommendation that the Council consider a Resolution of Support for the "Our Neighborhood Voices" Initiative. Although local control of land use decisions is a VCOG Priority, the majority of the Committee Members preferred not to make this recommendation before hearing from their respective cities on a position on the initiative.

Member Adam suggested the editor of the Pacific Coast Business Times, Henry Dubroff, be invited to provide a prospective on the County's economy. The Committee agreed and Mr. Dubroff will be contacted and invited to make a presentation at the January 13 VCOG Meeting. Member Kildee asked that we continue to seek a presentation on the water issue.

#### 8. Succession Planning-

 Nomination of Chair-Elect 2022 to Succeed 2022 Chair Kildee in 2023- Member Adam nominated Supervisor Carmen Ramirez. After some discussion, Chair-elect Kildee suggested that we simply call for nominations from the floor at the January meeting. The Chair-elect candidates would then be voted on in the order of nomination.  Discuss Administrative Committee Formation – Due to the uncertainty of the make-up of the Council since most governing bodies have not completed their reorganization in January, the Committee agreed that the Administrative Committee be appointed at the March 24, 2022, Committee Meeting. The members of the 2021 Committee would continue for that meeting.

At this point, Member Haney joined the meeting. (03:00 PM) Chair Cross white explained the discussion and conclusion the Committee had made to Haney and has agreed with conclusion to open nominations for the office of VCOG Chair-elect from the floor during the January 13, 2022, VCOG Meeting.

Adjournment - The conference call concluded, and the meeting adjourned at 3:00 p.m.



# GOVERNOR NEWSOM PROPOSES \$286 BILLION BUDGET


On Monday, Jan. 10, Governor Gavin Newsom released his budget proposal of \$286 billion for Fiscal Year 2022-23. This proposal represents a 9.1 percent increase over last year's total budget and anticipates a surplus of \$45.7 billion. The budget includes funding and policy updates for key priorities including:

- \$500 million proposed for the Infill Infrastructure Grant Program, spread across two years, and a \$300 million one-time augmentation to the Affordable Housing Sustainable Communities Program.
- \$9.1 billion transportation package that focuses on zero-emission vehicle efforts, increasing mobility options/rail, transit and active transportation projects, equity-related investments to reconnect communities and safety projects.
- \$1.2 billion for port and freight and goods movement infrastructure, including projects that increase goods movement capacity, and at port terminals, such as railyard expansions, new bridges, and zero-emission modernization projects.
- \$110 million for a training campus to support workforce training specifically to accelerate the deployment of zero-emission equipment and technologies.
- \$22.5 billion for the climate and opportunity budget, including assistance for low-income residents and neighborhoods to purchase zero-emission vehicles and expand charging access.

Temporary suspension of the Senate Bill 1 adjustment for the state gas
excise tax. This would decrease fuel tax revenues by \$523 million;
however, the Governor proposed to backfill the suspension with General

PROJECT 2: Localized Content for Documents, Presentations, and Public Information Programs – COMPLETE - Work Product has been completed, updated following 2021 Legislative Session and distributed. The Power Point information slides about RHNA "from the State to SCAG to each city" has been reviewed by SCAG were sent to each city staff contact.

**PROJECT 3: Regional Inclusionary Ordinance** – The Ordinance Template and Appendix has been completed and distributed to City Attorneys. VCOG Staff and Legal Consultant made a presentation to city planning group on January 20.

PROJECT 4: Regional ADU Program for Pre-Fabricated and Garage Conversion ADU's – VCOG Council approved the Final MOU with VCOG, OCCOG and GCCOG on January 13. VCOG Will be contributing \$70,000 in REAP Finds toward a total \$289,000 Project Budget. OCCOG Staff will take the lead role in developing the work products for general use by all including the public. The Scope of Work will receive some minor tweaks.

**PROJECT 5: Regional CEQA Streamlining VMT Adaptive Management and Mitigation Program** – Work is continuing with VCTC and our consultants led by Iteris, Inc. The latest Draft VMT Mitigation Program and Summary Memo are attached.

**Additional Grant Funds**: VCOG will receive an additional \$21,600 in REAP Funds as a supplemental allocation of excess funds from SCAG. These funds have been allocated to Project No. 4 to increase VCOG's contribution to \$70,000. (Budget Amendment approved by Council on January 13, 2022.


Housing Element Progress: VCOG is preparing an update on each priselection's Housing Element Progress. City staff provided their jurisdiction's current situation using the following selections:

## 1 Introduction

### 1.1 Purpose of the VMT Adaptive Mitigation Program

Senate Bill (SB) 743 changed the way that public agencies evaluate the transportation impacts of projects under the California Environmental Quality Act (CEQA), identifying vehicle miles traveled (VMT) as the most appropriate metric to determine the significance of transportation impacts. When a project exceeds the VMT thresholds of significance, the project is required to implement feasible mitigation measures to reduce CEQA transportation impacts related to VMT. Since the adoption of SB 743, lead agencies have been working to develop appropriate VMT numerical thresholds of significance, evaluate project VMT impacts, and identify how to mitigate projects that may have a significant VMT impact. While standard site-specific mitigation measures, such as increasing density or adding transit specific to a project site, are potentially available for reducing VMT impacts they are often not feasible and lead agencies have experienced difficulty achieving VMT reductions that meet applicable thresholds when applying available mitigation. Therefore, in partnership with the Ventura County Transportation Commission, the Ventura Council of Governments (VCOG) has identified the need for a regional mitigation program to provide alternative VMT mitigation measures, such as a fee program, bank, or exchange, for housing projects to achieve applicable VMT thresholds.

VCOG's goal is to develop a VMT adaptive mitigation program and supporting analyses that can be incorporated by its member agencies into the environmental documents related to their housing elements and programs. The program could reduce the need to prepare an Environmental Impact Report (EIR) and approval with overriding consideration by providing options for VMT-reduction features, and/or pay a VMT reduction fee or select from a list of pre-approved projects to reduce VMT, to fully mitigate a VMT significant impact through a Mitigated Negative Declaration (MND).

This report is intended to provide a general guide in assessing criteria for a VMT adaptive mitigation program for proposed projects under CEQA. The report provides information and guidance on the legal background, requirements, and methodology for creating a regional VMT mitigation program for housing projects. This document provides a discussion of the types of VMT reducing projects, local agency VMT thresholds, and the importance of considering factors such as project location, funding, and additionality when creating a VMT mitigation program.

#### 1.2 Background

#### California Environmental Quality Act

CEQA, enacted in 1970, requires lead agencies to inform decision makers and the public about the potential environmental impacts of proposed projects, and to reduce those impacts to the extent feasible. Lead agencies are state and local agencies that have the primary responsibility for approving a project. To be a CEQA lead agency, the public agency must have discretionary authority over a project. Lead agencies in Ventura County are local cities, , school districts, water districts, the County of Ventura, and other public agencies.

Mitigation Fee Act Requirements for VMT Adaptive Mitigation Program

The intent of this memorandum is for DTA to provide an outline of the Mitigation Fee Act requirements as they apply to the proposed VMT Adaptive Mitigation Program. As background, the levy of impact fees is one authorized method of financing the public facilities necessary to mitigate the impacts of new development. Impact fees are limited by both the California and federal constitutions, and further limited by the California Mitigation Fee Act (Government Code Sections 66000 et seq.). A fee is "a monetary exaction, other than a tax or special assessment, which is charged by a local agency to the applicant in connection with approval of a development project for the purpose of defraying all or a portion of the cost of public facilities related to the development project..." (California Government Code, Section 66000). A fee may be levied for each type of capital improvement required for new development, with the payment of the fee typically occurring prior to the beginning of construction of a dwelling unit or non-residential building. Fees are often levied at final map recordation, issuance of a certificate of occupancy, or, more commonly, issuance of a building permit.

AB 1600, which created Section 66000 et seq. of the Government Code, was enacted by the State of California in 1987, and requires that a public agency re-evaluate their Development Impact Fees every five (5) years and make findings that the funds collected are still needed to complete the identified projects and there is a reasonable relationship between the fee and purpose for which it was collected.

In 2006, Government Code Section 66001 was amended to clarify that a fee cannot include costs attributable to existing deficiencies but can fund costs used to maintain the existing level of service ("LOS") or meet an adopted level of service that is consistent with the general plan.

In 2020, Government Code Section 66019 was amended to require that any increase in the existing LOS must be justified, and that impact fees imposed on residential property must be on a per-square foot basis unless a different basis is justified in the study.

Section 66000 et seq. of the Government Code thus requires that all public agencies satisfy the following requirements when establishing, increasing, or imposing a fee as a condition of new development:

- 1. Identify the purpose of the fee. [Government Code Section 66001, subd. (a)(1)];
- 2. Identify the use to which the fee will be put. [Government Code Section 66001, subd. (a)(2)];
- 3. Determine that there is a reasonable relationship between the fee's use and the type of development on which the fee is to be imposed. [Government Code Section 66001,

subd. (a)(3)]; and

4. Determine how there is a reasonable relationship between the need for the public facility and the type of development project on which the fee is to be imposed. [Government Code Section 66001, subd. (a)(4)]

Additionally, for adjudicatory (ad hoc) fees, this Fee Study demonstrates how there is a reasonable relationship between the amount of each fee and the cost of the public facility or portion of the public facility attributable to the development on which each fee is imposed. [Government Code Section 66001, subd. (b)]

Presented below are the legal requirements as they relate to the calculation and imposition of a Vehicles Miles Traveled ("VMT") impact fee.

#### A PURPOSE OF THE FEE [GOVERNMENT CODE SECTION 66001(A)(1)]

The purpose of the proposed fee is to fund infrastructure, consistent with the VMT Adaptive Mitigation Program ("AMP") that would reduce and/or mitigate VMTs generated by future development. The VMT AMP guides local jurisdictions in evaluating VMT impacts for development projects and establishes (i) a baseline for mitigating future VMT increases resulting from new development, and (ii) a framework to identify multi-modal transportation infrastructure that mitigates future increases in overall VMTs resulting from future development. Specifically, any increase in VMTs resulting from future development, translates into greater impacts on the local jurisdiction's transportation network and regional greenhouse gas emissions. Therefore, such increases in VMTs from future development would be offset in each local jurisdiction, through the construction of transportation improvements that reduce overall local VMTs. The fee applicable to a given project will depend on the total VMTs generated by the project and the target VMT reduction level.

# B THE USE TO WHICH THE FEE IS TO BE PUT [GOVERNMENT CODE SECTION 66001(A)(2)]

The fee would fund a range of multi-modal infrastructure identified in each local jurisdiction's capital improvement program. These improvements would offset the increases in VMT resulting from future development, by reducing overall VMT in the respective local jurisdiction.

C THERE IS A REASONABLE RELATIONSHIP BETWEEN THE FEE'S USE AND THE TYPE OF DEVELOPMENT PROJECT UPON WHICH THE FEE IS IMPOSED (BENEFIT RELATIONSHIP) [GOVERNMENT CODE SECTION 66001(A)(3)]

As discussed above, the fee would be used to fund multi-modal improvements that reduce or mitigate VMT impacts of future development, and in turn reduce/mitigate impacts to the local mobility network and regional greenhouse gas emission levels. Notably, VMT impacts will be determined on a project-by-project basis for each new development, consistent with the VMT Adaptive Mitigation Program. Therefore, the fee attributable to a development project will be proportional to that project's VMT impacts.

D THERE IS A REASONABLE RELATIONSHIP BETWEEN THE NEED FOR THE PUBLIC FACILITY AND THE TYPE OF DEVELOPMENT PROJECT UPON WHICH THE FEE IS IMPOSED (IMPACT RELATIONSHIP) [GOVERNMENT CODE SECTION 66001(A)(4)]

New development within a local jurisdiction, irrespective of location, contributes to the direct and cumulative impacts on the mobility network and regional greenhouse gas emission levels. As a result, burden created by future development necessitates additional multi-modal improvements that reduce and offset VMT impacts of future development, consistent with

VMT AMP and each local jurisdictions capital facilities programs. As VMT impacts are determined on a project-by-project basis, the need for additional multi-modal improvements is directly linked to the increase in VMTs resulting from a development project.

THERE IS A REASONABLE RELATIONSHIP BETWEEN THE AMOUNT OF THE FEE AND THE COST OF THE PUBLIC FACILITIES ATTRIBUTABLE TO THE DEVELOPMENT UPON WHICH THE FEE IS IMPOSED ("ROUGH PROPORTIONALITY" RELATIONSHIP) [GOVERNMENT CODE 66001(B)]

As discussed previously, each individual development project and its related increase in population and/or employment, along with the cumulative impacts of all development in the County, will impact the overall VMT. In order to maintain the current quality of life, health, and safety, certain multi-modal improvements that reduce or mitigate such increases in VMT, would need to be constructed. Thus, the amount of the fee and the cost of improvements associated with the project, are proportional to the overall VMT generated by the project.

#### VENTURA COUNCIL OF GOVERNMENTS 2022 LEGISLATIVE PROGRAM

#### **PURPOSE**

The purpose of the Ventura Council of Governments (VCOG) Legislative Program is to protect and promote the regional interests of the governmental entities within Ventura County on priority issues and matters that may impact those entities. In this vein, VCOG's legislative efforts are intended to support the fiscal stability of local government, and to provide for and preserve local control of governance and service delivery. The annual adoption of a Legislative Platform will guide the VCOG Board (Board) and staff in evaluating and taking appropriate action upon legislative proposals introduced at the state and federal levels. The goals of VCOG's Legislative Program are to:

- Advocate the region's legislative interests at the state and federal levels;
- Inform legislators and the VCOG Board regarding key issues and legislation that could have potential impacts on the region;
- Participate with other Councils of Government, the Southern California
  Association of Governments (SCAG), the League of California Cities, the
  California State Association of Counties (CSAC), National League of Cities
  (NLC), Ventura County Transportation Commission (VCTC), and other
  regional agencies on legislative issues of importance to the region;
- Seek support and assistance for regional projects, services and programs that enhance public services

#### **PROCESS**

The VCOG Legislative Committee, comprised of staff from the ten cities, County, and the League of California Cities representative, shall review the status of legislative proposals and make recommendations to the VCOG Board consistent with the annually adopted Legislative Platform. In addition to the direction provided in the Platform, the Committee will consider positions established by the League of California Cities, California State Association of Counties, National League of Cities, and Southern California Association of Governments. VCOG will not address matters that are not pertinent to the region's local government services, such as partisan, socially divisive, or international issues.

When timely action is needed before the VCOG Board is able to convene to authorize a position, staff is authorized to prepare position letters for the Chair's signature, provided such position is consistent with the VCOG Legislative Platform or positions established by the League of California Cities, California State Association of Counties, National League of Cities or the Southern California Association of Governments. Should any of these positions be in conflict, no action will be taken without specific Board direction.

Should the Chair not be available to sign a position letter, the Vice Chair shall be authorized to sign the letter in lieu of the Chair. If neither the Chair nor Vice Chair is available, the Executive Director shall be authorized to sign in lieu.

All members of VCOG shall receive copies of position letters prepared on behalf of VCOG.

#### A. LAND USE AND ENVIRONMENT

- Support legislation to extend CEQA streamlining provisions for land use projects that are consistent with the SCAG Sustainable Communities Strategy.
- Support use of cap-and-trade revenues and other funding sources for local planning activities to implement the regional Sustainable Communities Strategy.
- Seek to ensure any future funding for SB 375 implementation includes funding for local initiatives.
- Support legislation that streamlines the environmental review process for mixed-use infill development without compromising environmental quality standards.
- Support legislation and/or funding for remediation of superfund sites.

#### B. HOUSING AND BLIGHT

 Support efforts of the League of California Cities, California State Association of Counties, Association of California Water Agencies, and California Association of Sanitation Agencies to establish an optional funding system for local agencies to finance storm water management, flood control, sewer and water supply projects, set rates to encourage conservation, and reduce water and sewer bills for low income customers.

#### E. SOLID WASTE MANAGEMENT

- Support legislation pertaining to VCOG's responsibility for approval of the regional solid waste plan.
- Support legislation that promotes long term, cost beneficial recycling and conversion technologies.
- Support extended producer responsibility (EPR) legislation that encourages manufacturers to design environmentally friendly products.
- Oppose legislation that would restrict or limit local government's ability to franchise refuse and recycling collection services, to direct municipal or county solid waste flow (flow control), to contractually require haulers to guarantee achievement of AB 939 goals, or to local government's ability to protect landfill capacity.

#### F. PUBLIC SAFETY

- Support legislative efforts that strengthen local law enforcement's ability to prevent and reduce crime.
- Support funding opportunities for local law enforcement activities and emergency preparedness
- Support increased local authority and resources to address impacts of early prisoner release policies and criminal recidivism.
- Support legislation that provides funding and resources to local governments to prevent wildfires, mudslides, and other disasters..

#### G. RESOURCES MANAGEMENT

 Support and encourage regulations and procedures that promote common sense implementation of State and Federal water quality control laws, and ensure State and Federal agencies work in collaboration to enable compliance with these laws.

- Support legislation to increase the availability and viability of energy efficiency and renewable energy options for public agencies, residential, and commercial customers.
- Support programs to ensure provision of a safe and reliable water supply.
- Oppose legislation that imposes new regulatory burdens on municipal utility systems without providing funding and/or consideration of the feasibility of monitoring and mitigating such requirements.

#### H. LOCAL GOVERNANCE SUSTAINABILITY

 Support legislation that protects local control and ensures equitable, dependable and predictable funding for vital community services.

#### I. PUBLIC HEALTH

- Support legislation that protects public health and preserves quality of life.
- Encourage the state of California to fund and sponsor further research into the negative impacts of anticoagulant rodenticides to determine whether the use of these products should be further restricted or banned statewide.
