Broadband Standing Committee Progress

- Main goals: Improve broadband accessibility, enhance quality, and lower prices through increased competition
- Creating an information sheet for internet service providers, with permitting contacts and requirements for each city
- Working toward standardized micro-trenching requirements across cities
